- Blue Shield SENEGAL (BSS) has defined a policy for the deployment of BS in Africa: with the case of Mali, which has just been accredited, and that of Niger, which has its committee under construction. BSS is in the process of mentoring other African countries by contacting colleagues from these countries for the establishment of their national Blue Shield committee: Gambia, Uganda, Malawi, Zambia, Kenya, Togo, and Mauritania...
- BSS develops a policy of adherence of young people to the ideals of BSI, especially young heritage students;
- BSS is currently in negotiations with the ministries of culture and tourism of Senegal for the development of the Senegalese cultural passport, and with the Ministry of the Armed Forces of Senegal to integrate BSI's objectives into its missions.
