3.1 - Law, policy development and implementation:

Dialogue between the Ministry of Culture and Education and BS Iceland took place in 2021. BS Committee members, Nathalie Jacquiment and Karen Sigurkarlsdóttir, had a meeting with Rúnar Leifsson, senior advisor at the Ministry. The topic was the absence of a substantial Emergency policy for cultural heritage in crisis in the country. The meeting took place because of the Seyðisfjörður Landslide which took place in East-Iceland in December 2020 causing severe damage to towns museums. There has been limited response from the ministry but the government structure in Iceland undertook great restructure at the end of the year in the aftermath of General Election in September 2021. Further dialogue with the new ministry of Culture and Business Affairs, where cultural heritage is now places, is aimed to take place in 2022.

3.2 - Education, training, and capacity building:

Due to the Coronavirus there was a minimal activity in the committee. Yet the committee maintained and added material to its media outlets (website and Facebook page). The main focus was on finding new date for a conference on protection of cultural heritage in Iceland (which was postponed in early 2020) but do the pandemic the planning was halted throughout the year. However, planning resumed in the fall of 2021 and the conference is planned on May 5th 2022.
