3. Report of Activities: Achievements & Performance

3.1 - Law, policy development and implementation:

- Participation of several BSB members in the working group for the protection of cultural property within the Interdepartmental Commission for Humanitarian R (ICHR) managed by Mr. Benjamin Goes at the Prime Minister's Chancellery (virtual).
 We receive all documents and information on the preparation for the implementation of the Convention for the Protection of Cultural Property during armed Conflict (The Hague, 1954) and its two Protocols of 1954 and 1999. The Brochure is not yet published.
- BSB made an intervention on its actions during the floods (M. Serck, 29/09/2021) and contributed to the "Floods" report of the WG Cultural property. The ICHR would speak under the National Advisory Committee referred to in Resolution II of the 1954 Hague Conference.

3.3 - Proactive protection and risk preparedness:

- BSB received a grant of €20,000 for a project submitted to the AwaP (Walloon Agency for Cultural Heritage) "For the implementation of actions relating to the protection of protected heritage in case of disasters and emergency situations". The document was signed on November 12, 2021 by the Minister of Heritage Valérie de Bue. Duration: from September 1, 2021 to August 31, 2022.
 - As part of this project, administrative and technical assistance was hired for 6th months from December 1st at the rate of one day per week (freelance status).

3.4 - Emergency response in disaster, domestic emergencies, and armed conflict:

The flood that affected mostly the Walloon Region was the result of the heavy rains on the 14th and the 15th of July. On the 20th of July a **crisis committee** was set up by the Royal Institute for Cultural Heritage (KIK-IRPA) and BSB. The various institutions and governmental and private organizations, working in the field of cultural heritage, were invited to work closely together. Since then, the crisis committee has met (via Teams) 8 times: July 20 and 27, August 3, 10, 17 and 14, September 8 and October 22.

BSB actions in the context of this disaster:

-	July 15: BSB is alerted by the managers of the Museums of Liège and Verviers. The
	network is activated and specialists are on site July 17, 2021.
-	July 16: a member of the Board of Administrators offers to be our SPOC with a unique
	telephone number.
-	End of July: an online form is available on BSB website to both recruit volunteers and
	collect requests for intervention. < https://blueshieldbelgium.be/fr/formulaires-pour-
	les-demandes-et-propositions-daide/ >
-	For several months, and this on an almost weekly basis, calls for intervention were
	prepared and sent by email to volunteers with all the information required. The
	follow-up was quickly organized by a few members of the Board and is still active,
	with the administrative and technical assistance that BSB was able to recruit with the
	grant of the AWAP starting December 1, 2021.
-	At the end of 2021, more than 170 people came forward as volunteers: specialists,
	institutions, heritage agencies, private firms and people interested in the field from all
	over Belgium and also from France.
-	More than 100 man-days were supplied.
-	Universities (conservation/art history/archaeology, etc.) have been contacted and are
	deploying their students in the field.
-	Heritage institutions were asked to lend equipment, such as dehumidifiers and
	protective clothing for the affected places.
-	BSB also worked on communication to strengthen the image of the association
	through conferences (communication by Mr. Serck on the floods at the WAPI
	congress in Tournai, 08/21/2021), interviews, the website, Facebook posts
-	-At the request of BSI, the committees of Belgium, the Netherlands and Germany
	wrote a report on the situation (sent on 15/08/2021)

3.5 - 9	tabilisation, post-disaster recovery, and long-term/ongoing support:
-	A number of organizations present in the Crisis Committee met in a 'Circle of Donors',
	created within the King Baudouin Foundation. BSB made calls for donations and
	helped to activate the Circle of Donors (meetings 28/10/2021, 18/11/2021).
-	BSB took part in the working group related to the insurance of volunteers (personal
	accidents). The Firm Eeckman, expert in the field, advised us free of charge. We are
	very grateful for it.
-	BSB has received an authorization from the ONEM allowing the unemployed to carry
	out a voluntary activity while retaining their unemployment benefits.
-	26/10/2021 Some members of the Council visited a provincial heritage depot in
	Ename, specially equipped to intervene preventively and curatively in crisis situations.
-	23/11/2021 A study day "Drawing lessons from the crisis" is organized by the crisis
	committee to draw up an initial assessment (face-to-face at IRPA and remotely via
	Teams). Several organizations including BSB (G. Janssens, B. Claes, AS. Hanse) gave
	lectures.
3.6 - Co-oi	dination (of Blue Shield and with other relevant organisations):
-	14/10/2021
	The Belgian Blue Shield Committee attended the UNESCO Vlaanderen meeting. A
	discussion on the impact of the flooding took place in a private session. B. Claes and
	M. Serck gave an overview of Blue Shield actions after the disaster and also explained

how Blue Shield deploys and guides the many volunteers. N. Absil (AWaP, Liège), gave an assessment of the state of the protected buildings after the flood. B. Claes and L. Verhaegen take part in the 'Calamities' think tank of Faro (meeting on 12/10/2021).

4. Main issues faced:

The great flood in Belgium, Wallonia, has forced BSB **to react quickly, appoint a SPOC and mobilize volunteers**. Fortunately, an existing network and a lot of voluntary commitment from some core members of the Board made this possible.

- BSB needs to develop **a permanent centre** that can be activated in time of crisis.
- It is also necessary to obtain a representation in the crisis bodies of the government on different levels (Municipality, Province, federal State).
- BS movement has to gain more fame by
 - pursuing a high-quality media policy
 - Organize own fundraising

5. Future goals

This are only a few goals on the short term

- Develop our organisation to be more efficient and to reinforce our financial strength
- Maintain the contact with our volunteers in the follow up of the disaster
- Prepare projects to obtain a better financial support of the government (different levels, Flanders, Wallonia, federation Brussels-Wallonia...)
- Encourage member to follow training in the areas of prevention of disaster and on good practices after the disaster
- Deliver this information to others inside and outside BSB
